



Subsidized Child Care in New York State (Federal Fiscal Year 2015)

- \$794 Million allocated to local districts for the NYSCCBG child care subsidy program in SFY2015-16.
- \$5 million included in SFY 2015-16 as a grant to districts who agreed to use funds to expand availability of subsidized child care in their districts.
- Approximately 207,000 children in 123,000 families received child care subsidies in FFY 2015 (annual).
- Approximately 126,000 children in 75,000 families received child care subsidies <u>each month</u>.
- Approximately 65% of children served are from NYC.
- Approximately 47% of children served received low income subsidies, while 53% of children with child care subsidies also received Temporary Assistance.
- There are approximately 24,000 legally exempt providers enrolled to provide subsidized child care.

Division of Child Care Services Miscellaneous Contracts for SFY 2015-16

- 32 Child Care Resource & Referral Contracts \$19.9 million (includes New York City with one lead and four subcontractors).
- Seven Infant/Toddler lead agencies \$1.1 million.
- 38 Registration agencies with a budget of \$18.5 million.
- Child care subsidy project memoranda of understanding (MOU) for income-eligible families: SUNY \$2.213 million; CUNY \$2.161 million.
- NYS Agriculture & Markets supports Centers for children of migrant and farm workers \$2.504 million.
- Unified Court Systems Children's Centers \$150,000.

Advantage After School Program: Approximately 15,000 children and youth served through 117 contracts with 155 program sites - \$19.3 million.

- •<u>DCC=Day Care Center</u> provide care to an enrolled group of 7 or more children at a facility other than a personal residence. Maximum capacity is driven by square footage allowance.
- •FDC=Family Day Care Home provide care to more than 2 non-relative children in a residence. Max. capacity: 8 children / caregiver.
- •GFDC=Group Family Day Care Home provide care to more than 2 non-relative children in a residence. Maximum capacity: 16 children / 2 caregivers.
- <u>SACC=School Age Child Care</u> provide care to an enrolled group of 7 or more children in a non-residence facility outside normal school hours. Maximum capacity is driven by square footage allowance.
- •<u>LE=Legally Exempt Enrolled</u> providers of subsidized child care services, who are not required to be licensed or registered, but who meet minimum health and safety standards required for enrollment.
