This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

This fatality concerns the death of a male child that occurred on 7/28/15. The male child was born on 7/26/15 and immediately presented with respiratory difficulties. The male child and mother were admitted to another area hospital to provide intensive care to the male child.

During his stay in the intensive care unit the child's medical condition deteriorated and following a code, was pronounced deceased on July 28, 2015 at 5:22am.

Executive Summary

This fatality concerns the death of a male child that occurred on July 28, 2015 in Monroe County. The SC was born in the hospital on July 26, 2015. The cause of death was natural, caused by primary pulmonary hypertension, as listed on the death certificate. An SCR report with allegation of Parent Drug Misuse was received on July 26, 2015 due to a positive THC test by the mother following the birth.

According to information received from the attending hospital, the SC almost immediately began to have respiratory difficulties following birth. The SC was transferred to another area hospital for neonatal intensive care. The SC continued to have difficulty and on 7/28/15 at 5:22am, following a code and despite efforts, was pronounced deceased.

Monroe County Department of Human Services (MCDHS) began their investigation on 7/26/15 following the report of the positive THC test by the BM. The SC tested negative for THC prior to his death. MCDHS made collateral contacts and visited with the BM and SC in the hospital and completed an adequate safety assessment.

Following BM's discharge from the hospital BM and BF were uncooperative with contact from MCDHS. MCDHS made repeated attempts, letters and home visits, to complete their assessment and follow-up related to a 12 yr. old sibling in the home. MCDHS was finally granted access to the family members on 8/12/15, completing interviews with all family members except the BF, as he continued to refuse. The OC was deemed safe in the care of his BM and Step-father. MCDHS also visited the BF for the OC and completed an assessment related to time spent in his home. Again, OC was deemed safe in his care. He was not aware of any information related to the death of the SC.

MCDHS offered counseling for substance use and grief services to the family. Those services were declined. No autopsy was performed, as the family declined.

MCDHS gathered information about the circumstances of the newborn's death from the parents, the mother's obstetrician, and the hospital social worker and attending physician. They obtained copies of the hospital records and death certificate. 9/15/15 it was confirmed by the hospital physician that the THC use by the BM was in no way related to the death of the SC.

On 9/15/15 MCDHS appropriately unfounded the allegation of Parent's Drug Misuse due to no credible evidence that SM was neglectful to OC. It was confirmed that SM's THC use had no association with SC death.

MCDHS case activities were timely and documentation was thorough and concise. MCDHS is to be commended.

LDSS Response

On 7/26/15 The SCR received a report of a child fatality on an open CPS Investigation. The SM had tested positive for THC and an allegation of Parent's drug misuse was initiated. The SC was having difficulty immediately following birth and was transferred to another hospital for intensive care. SC continued to struggle and was pronounced deceased on 7/28/15.

MCDHS arrive at the hospital on 7/27/15 and interviewed the SM and assessed the infant. MCDHS did follow up and visit with the SM and OC in their home following the death of the SC. BF was uncooperative during the investigation. The OC was deemed safe in the care of his parents. OC was interviewed and was unaware of substance use in the home and related that his BM and Step father were available for his care. The home had an adequate food supply and did not present any health and safety concerns.

Collateral contact with the attending physician, hospital social worker, OC school noted no concerns. MCDHS offered bereavement counseling and substance abuse treatment to the SM. She declined. MCDHS interviewed the BF of the OC. He had no concerns about the care of his son by the BM. BF declined an inspection of his home relating that he had adequate food and a room for his son when he visits.

MCDHS closed the investigation determining there was no credible evidence that the Mother's use of THC was neglectful to OC or associated with the death of the SC.
