This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns: A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
The death of a child for whom child protective services has an open case.
The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child's family; any extraordinary or pertinent information concerning the circumstances of the child's death; whether the child or the child's family received assistance, care or services from the social services district prior to the child's death; any action or further investigation undertaken by OCFS or the social services district since the child's death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child's household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may <u>only</u> be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child's siblings or other children in the household.

OCFS' review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS' assessment and the performance of these agencies.

Presenting Information

An SCR report was received with concerns that on 8/12/20, the two-month-old subject child died while in the care of a maternal uncle. The uncle had no explanation as to how the child died. There were further concerns the uncle and the child's mother had histories of substance abuse. The eldest sibling's father was also using illicit substances and physical altercations between him and the mother occurred in the presence of the children. The roles of the child's father, and the younger sibling's father were unknown.

Executive Summary

This fatality report concerns the death of a two-month-old male subject child that occurred on 8/13/20. An SCR report was made on that same date with allegations of Parent's Drug/Alcohol Misuse, Inadequate Guardianship and DOA/Fatality against the child's mother, father and maternal uncle. There were additional allegations of Inadequate Guardianship and Parent's Drug/Alcohol misuse against the child's mother and the biological father of one of the siblings. Oswego County Department of Social Services (OCDSS) received the report and investigated the child's death. An autopsy was completed, and the cause of death was noted as asphyxia due to becoming wedged between back pillows. The manner was accidental.

At the time of the child's death, he resided with his mother, maternal uncle, and two siblings, ages two and five years old. The child's biological father was involved in his life; however, did not live in the residence. The child also had half-siblings who did not visit the home. The investigation revealed that on the morning of 8/13/20, the uncle was asleep with the child on a sectional sofa, and the siblings were asleep upstairs in their room. The child was sleeping atop three pillows and a folded comforter. The father and mother left the home at approximately 8:30AM, without waking or informing the uncle. The uncle awoke at approximately 10:50AM and found the child face down with his head wedged into a couch cushion and the back of the sofa. The uncle called emergency services who arrived shortly thereafter and transported the child to a local hospital, where he was pronounced deceased at 11:24AM.

From the time the investigation began to the time of its closure, OCDSS spoke with family members and numerous collateral sources. There were no criminal charges brought against the parents regarding the death of the child. Concerns arose surrounding substance use and mental health issues involving the mother, father, uncle and biological father of the five-year-old sibling. In response, OCDSS removed the children from the home and filed a neglect petition in family court. Due to the parents' failure to leave the children with appropriate supervision, and their knowledge that the child was sleeping in an unsafe environment, OCDSS substantiated the allegations in the report regarding the fatality. A mandated preventive services case was opened and ongoing at the time of this writing.

LDSS Response

On 8/12/20, OCDSS received the SCR report regarding the death of SC, which occurred on that same date. OCDSS initiated their investigation within 24 hours and coordinated their efforts with their multidisciplinary team. OCDSS discovered there were two SS in the home and worked promptly to assess their safety.

On 8/12/20, safety plans were implemented on behalf of the SS, and home environments were assessed; no concerns were noted. OCDSS also assessed the SS and found they were safe in the care of their caregivers per the safety plan.

On 8/13/20, the 5yo SS was interviewed by LE, while OCDSS observed. The 5yo explained she and her sister awoke the previous morning and were going up and downstairs sneaking cookies from the kitchen. The 5yo stated they saw MU asleep on the living room couch with SC, and that he was the only adult home. She said SC was under a blanket and looked "brown." The 5yo reported she and her sister went upstairs to watch TV, and then heard a noise. She reported they went downstairs and saw a police officer holding SC. The 5yo had no further information surrounding the incident. On this same date, OCDSS observed LE interview SM and SF. SM explained SF spent the night on 8/11/20 and slept downstairs with MU and SC; SM slept upstairs. SM stated when she awoke the next morning, SF had to go to work and she decided to go for a walk. She said she thought she had heard SF tell MU to keep an eye on the kids as they were leaving; all 3 CHN were asleep, and MU also appeared to be "in and out" of sleep. SM said she looked at SC right before leaving the house. She denied she told MU to watch the CHN while they were gone and then reported she did not actually hear SF tell MU to watch the CHN either. SM stated SF did not have to go into work after all and joined her on her walk. SM reported some time later, MU called her screaming that SC was not breathing. Information from LE noted SM and SF left around



8:30AM and received the call from MU at 10:51AM. SF's account of events corroborated SM's, and he reiterated he had told MU to watch the CHN as he and SM were leaving the house.

Additional concerns arose regarding SM's untreated substance abuse and mental health, as well as the concern surrounding supervision. Due to this, the SS were removed from SM on 8/17/20, and a petition was filed in family court. At that time, the 5yo was placed in the care and custody of a family friend, while the 2yo SS was ordered to remain in the care of her BF.

Through speaking with collateral sources, OCDSS learned SC had been placed to sleep atop 3 pillows and a folded comforter, and those items were nearly as high as the back of the couch. A gap between the couch cushions where SC was found was also observed. LE reported SC was found face down, with his head wedged between the cushions and back of the couch, A bassinet and Pack 'n Play were observed in the home, and the parents had been previously educated surrounding safe sleep practices.

OCDSS' attempts to interview MU were unsuccessful; however, upon speaking to LE, OCDSS learned neither SM nor SF woke MU or informed him they were leaving that morning. When MU found SC unresponsive with his head in between the couch cushions, he immediately called SM and emergency services. MU had a history of substance abuse including overdosing in the presence of SM's CNH. SM was aware of these concerns yet still allowed MU to be alone with SC and the SS.

Throughout the investigation, OCDSS spoke with collateral sources and assessed the safety of all SS. Safety and legal interventions were sought when necessary. LE found no criminality on behalf of any of the adults in the home regarding SC's death. The ME noted there was no physical trauma to SC and he likely suffocated. OCDSS found evidence SM and SF placed SC at imminent risk by leaving and not waking MU to care for the CHN. The investigation was indicated, and a mandated preventive services case was opened.
